



CALL IT OUT FIRST NATIONS RACISM REGISTER

PROJECT OVERVIEW

The Call It Out First Nations Racism Register (callitout.com.au) was officially launched on 21 March 2022 to coincide with the International Day for the Elimination of Racial Discrimination and is led by the Jumbunna Institute for Indigenous Education and Research (Jumbunna Research), in partnership with the National Justice Project (NJP). Together, we are exposing and resisting racism in Australia.

Call It Out is a register of all forms of racism and discrimination towards First Nations Peoples.

- Anyone can make reports – First Nations people, bystanders and allies.
- Anything that you feel is unfair or unjust towards First Nations People based on race can be reported (e.g. interpersonal or structural bias, prejudice, or discrimination).
- Reports can relate to current, historical or ongoing racism that occurs anywhere – at an organisation or while interacting with a government service, in public or private, in the media or online.
- You can provide as much or as little detail as you are comfortable with in your report, and all personal information remains confidential and secure.
- The register is ongoing – reports can be made 24/7/365.
- These reports are collected, held securely and analysed by Jumbunna Research to inform [annual reports](#) to help raise awareness and drive systematic change.

By calling out racism, you are contributing to a collective story and helping to expose and resist racism in Australia.





PROJECT IMPACT

Call It Out was created to build an evidence base to combat the ongoing denial of the existence and negative impacts of racism on all aspects of First Nations people's lives, including social and emotional wellbeing.

Our purpose is to collect information on the nature, extent and impact of racism on individuals and communities, as well as to inform strategies on how to respond to and address racism. This information will inform evidenced-based research to inform anti-racism action and policy development, support the response of First Nations communities, organisations and leaders, and educate the wider community.

These stories do not belong to us. We want Call It Out to be genuinely beneficial to community organisations and Aboriginal and Torres Strait Islander Peoples and we respect Indigenous Data Sovereignty.
